- Have a valid customer shipping address.







- Scroll down to Customer Delivery Service and click Start Now.










HOW DO I USE CUSTOMER DELIVERY **SERVICE?**

SHIPPING AND FULFILLMENT

Delivery Made Easy

With multiple shipping options in the continental U.S., Customer Delivery Service allows you to ship orders generated from your Mary Kay[®] Personal Web Site or from a sales ticket.

You have two shipping options for CDS orders.

- U.S. Postal Service costs \$3.50*
- UPS costs \$7.00*

The UPS option will deliver faster than the U.S. Postal Service option. The shipping and handling fee for CDS orders to Alaska, Guam, Hawaii, Puerto Rico and the U.S. Virgin Islands is \$37. We currently cannot ship overseas or to the Dominican Republic.
